Brief Description	The project is a rehabilitation and upgrading of the University lighting system. The scope of work includes earthworks, structural works, and installation of 96 sets solar lightings

Prospective bidders should have completed within five (5) years from the date of submission and receipt of bids, a contract similar to the project with an amount of at least 50% of the ABC. Interested bidders must have key personnel and equipment (owned, leased or under purchase agreement) available for the prosecution of the project. The list of minimum equipment requirement is indicated in the Eligibility Forms.

Bidding shall be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the “Government Reform Act”.
