

B. Program Accreditation

Accreditation survey visits by the Accrediting Agency of Chartered Colleges and Universities in the Philippines, Inc. (AACCUP) for the various degree programs of the University was requested at the start of year. Survey visits for **7 programs under Level IV Phase 2 and 6 degree programs under Level II** were conducted in November.

Including the results of the survey visits conducted this year, forty-seven degree programs being offered at the La Trinidad campus are accredited at various levels. Majority of the degree programs (21) have Level III Accreditation.

D. Program Certification


The University applied for the **Certification of Program Compliance (COPC)** to the Commission on Higher Education for the various degree programs being offered at the main campus. A team from CHED Regional Office visited the University and evaluated the programs on December 5-16, 2016.

The COPC for Master of Science in Environmental Science was issued by CHED on October 27, 2016 and the program is to be offered starting second semester of SY 2016-2017.


II. STUDENTS

A. Enrolment


There was a total of 10, 534 students during the second semester of SY 2015-2016. This number decreased to 9,295 students during the first semester of SY 2016-2017. The decrease in enrolment was mainly due to the implementation of the K to 12 educational system. There were 2572 enrollees during the Summer term.



Distribution of enrolment by academic level





Distribution of enrolment by academic units



B. Graduates


There were 1,906 graduates in 2016, 1,773 are graduates of the La Trinidad campus, 63 of Bokod Campus, and 66 of Buguias Campus. Two magna cum laude and 55 cum laude led the 1378 graduates of baccalaureate degrees in the La Trinidad Campus. One hundred thirty eight were (138)conferred with masteral degrees and twenty-two (22) with doctorate degrees. The colleges that produced the most number of graduates are CA (479), CTE (456), and CHET (295).






In addition, 48 students completed the Certificate on Community Health Development which is a module programunder the Municipal Leadership and Governance Program (MLGP), a public-private partnership between Benguet State University, Department of Health Regions I, II and CAR, Zuellig Family Foundation, and the United Nations Fund for Population Activities (UNFPA). The participants were Mayors (24), Municipal Health Officers (23), and a Public Health Nurse (1) of the various municipalities in the regions.

On the other hand, 146 students completed language programs under the International Language Center during the year.



C. Performance in Licensure Examination

A very good performance was noted in the majority of the licensure examinations taken by BSU graduates. BSU ranked number one nationwide among the top performing schools in the Nurse Licensure Examination and number three in the Licensure Examination for Guidance Counsellors. Ms. Leny O. Estacio and Ms. Hylene S. Tayaban, graduates of Master of Arts in Guidance (MAG) ranked 6th and 9th respectively in the Licensure Examination for Guidance Counsellors while Ms. Agustina Puclo ranked 4th in the Veterinarian Licensure Examination.



D. Student Awards

Students of the University have garnered various awards in different national, regional, and local competitions. Among these awards, students were qualified at the national level for the search for Ten Outstanding Students of the Philippines (TOSP).



Other awards are for skills competitions sponsored by national and regional scientific and professional organizations and private companies. Most notable awards include:



Apart from the recognitions in academics, university students also bested other schools in sports competitions such as in the Baguio-Benguet Educational Athletic League (BBEAL). In the baseball event, BSU Wildcats championed the sport along with Wushu and Football events.

In Journalism, the Mountain Collegian, the official student publication was hailed as the 1st runner up in the Regional Higher Education Press Conference and was conferred as having the "Best Practices in Campus Journalism in the Philippines" by the School Press Adviser's Movement.

E. Student Scholarships





III. FACULTY

A. Faculty Profile

The University has a total of 413 faculty members, 342 or about 83% of which hold permanent positions while the remaining 71 are serving under Contract of Service (COS). Majority (354) are from the La Trinidad campus, 22 are from Bokod Campus and 37 are from the Buguias Campus.

Of the 342 faculty members who are holding permanent positions, there are 41 who are full-fledged professors. Majority (144), however, hold Instructor positions. In terms of highest educational attainment, there are 117 faculty members were Ph.D. degree holders, 200 are MS/MA degree holders, and only 25 or 7% are BS/BA degree holders.

B. Faculty Development

In order to improve and/or maintain the University's faculty profile in terms of educational qualifications, faculty members are encouraged to go for advanced studies.

There is an increase in the number of faculty members who went for advanced studies during the year along with the implementation of the K to 12 educational system. Sixty eight faculty members are currently taking up advanced studies.

Sixty three faculty members are taking up their advanced degrees in various universities in the country while two are studying abroad, one in Australia and another in the United States of America. Majority is studying at the University of the Philippines Los Baños (13), Saint Louis University (11), Benguet State University (11), and Don Mariano Marcos Memorial State University (10).

Twenty three faculty members were given scholarships for advanced studies by the Commission on Higher Education during the second semester of SY 2015-2016.

In order to improve the facilities at the Library, a new server was purchased. A total of 179 titles of books were also procured during the year.


C. Health Services

D. Student Services

The Guidance and Counseling Unit conducted a total of 14,479 consultations and monitoring in 2016. These were in the forms of individual inventory, individual guidance and counseling, parent conferences, interviews, meetings and group guidance. The unit also conducted one home visit during the year.

The Testing and Materials Development Unit (TMDU) administered the BSU-CQE to 598 applicants. The master list and rank lists were forwarded to the OUR and the different colleges. In addition, the unit administered the BSU-Elementary Laboratory School Entrance Examination (194 examinees), BSU-Secondary Laboratory School Entrance Examination (902 examinees), and BSU-Senior High School Entrance Examination (154 examinees). Personality tests were also administered to a total of 886 students.

Vocational and Placement Unit had implemented their regular programs during the year. The unit had deployed 85 Student Assistants (SA) during the 2nd semester SY 2015-2016 and 80 SAs during the 1st semester SY 2016-2017 under the Student Assistantship Program. Under the Special Program for the Employment of Students (SPES), 51 grantees were deployed during the summer term 2016. The unit also implemented the Labor Education for Graduating Students (LEGS) with the participation of DOLE, POEA. PRC and DOJ, The activity benefited 1500 graduating students. A Job Fair was conducted on June 30, 2016 at the BSU Gymnasium. This was participated in by 29 local companies and 7 overseas agencies with 1,455 job registrants/applicants.






The Benguet Vegetable Processing Center was able to implement five (5) technology programs/projects for 2016, while seven (7) technologies were generated and commercialized.



University Business Affairs

The Office of the Vice President for Business Affairs is the steward of partnerships and leasable properties under the production function of the University.

The University Business Affairs (UBA) operated and managed various income generating projects and leasable properties of the University. It continued to provide quality products and services to the faculty, staff and students of the University, and stakeholders.


During the year in review, UBA generated a net income of PhP 6.6 M from IGPs and 19M from leasable properties. The University had a profitability ratio (Net Profit/Gross Expenses) of 11.46% from all of its IGPs.

I. ADMINISTRATION AND THE BOARD OF REGENTS

Dr. Jones K. Feliciano served as Officer-in-Charge of the Office of the President from December 6, 2015 until March 16, 2016 when the Board of Regents conducted the final interview of the applicants and eventually elected Dr. Feliciano G. Calora, Jr. as the 6th president of BSU. The Turnover Ceremony was held on April 5, 2016 and the investiture of Dr. Calora was held on May 17, 2016. The investiture was attended to by the members of the Board of Regents (BOR), officials from different line agencies, other State Universities and Colleges (SUCs), and Local Government Units (LGUs), and other guests.

Outgoing or past members of the BOR were awarded with Plaques of Appreciation. Awarding for Dr. Silardo B. Bested (representative of Cong. Roman T. Romulo, Chair of Congressional Committee on Higher Education) and Atty. Vivian Eustaquio (representative of Sen. Pia S. Cayetano, Chair of Senate Committee on Higher Education) was held on June 22, 2016 during the 179th BOR Meeting while for Mr. Malcom C. Bacuso (Private Sector Representative from November 18, 2014-October 13, 2015), it was done during the Centennial Celebration on September 30, 2016.

Three new members, who had their oath taking on three different occasions, joined the BOR during the year. Faculty Regent, Louisa P. Pladio took her oath on June 22, 2016; Student Regent, Mark Neil B. Pageet on November 7, 2016 and Private Representative, Atty. Delmar O. Cariño on December 22, 2016.

The Board of Regents (BOR) had five board meetings in 2016 where 131 resolutions were passed. Among these are: BOR Resolution No. 2452, s. 2016, which approved the appointment of Dr. Calora as president of BSU from March 17, 2016 to March 16, 2020; and BOR Resolution No. 2464, s. 2016, Memorandum of Agreement between BSU and DepEd-CAR on the phasing out of the high schools in Bokod and Buguias campuses.

II. STRATEGIC PLANNING

The preparation of the University's Strategic Plan for 2017-2020 started with the crafting of the new Vision, Mission, Goals and Objectives (VMGO) and Core Values of the University. The workshops were done during two (2) special Administrative Council Meetings. The VMGOs were presented to the Board of Regents and were conditionally approved through BOR Resolution No. 2494, s. 2016. The Organizational Chart was also reviewed, revised and discussed as part of the agenda during the regular Administrative Council Meetings.





In order to prepare the University's Strategic Plan for 2017-2020, the different sectors and the offices under the Office of the President conducted their own workshops to prepare their respective strategic plans. The draft strategic plans of the different sectors were presented during the preplanning workshop of the executive committee. The University Strategic Planning workshop was conducted on October 18-19, 2016. The output of the workshop was a draft University Strategic Plan for 2017-2020.



III. HUMAN RESOURCE

In 2016, a total of 47 permanent and 464 Job Order (JO) or Contract of Service (COS) appointments were issued. Of the 47 permanent positions, 14 are for teaching positions while 33 are for non-teaching positions. Ninety-one (91) of the JO/COS appointments are for teaching positions and 373 are for non-teaching positions. Step-increments for 122 employees were also processed during the year by the Human Resource Management Office.

A total of 81 employees were assisted with various kinds of scholarships provided by the University (56) and by the Commission on Higher Education (25). These scholarships vary from full scholarships for doctorate and masteral degrees, to dissertation or thesis assistance, and sabbatical grants. Fifty four (54) employees were also provided assistance for short-term foreign travels for those who presented papers, served as resource person or participated in trainings, seminars or conferences. In addition, two faculty members were granted sabbatical grant during the year.









In addition to scholarships, grants and support for participation to trainings outside the University, the University conducted trainings for employees. In 2016, 30 trainings were conducted with a total of 1772 participants.



A total of 1519 payrolls and vouchers amounting to Php 463,540,587.85 were prepared by the Compensation, Benefits, and Other Obligations (CBOO) Office. This includes various types of compensations and benefits that the employees are receiving from the University; tuition fees and other benefits of local scholars; remittances to various agencies, banks and lending agencies; utility obligations; and others.



The applications of the employees for loans were also facilitated at the Administration Services Division. Applications for loans from the BSU Multi-Purpose Cooperative, Government Service Insurance System (GSIS), and Land Bank of the Philippines (LBP) were facilitated at the CBOO while application for loans from Pag-IBIG were facilitated at the Human Resource and Management Office (HRMO).



IV. SAFEGUARDING BSU LAND RESERVATION

The Land Reservation Office (LRO) conducted inspection and monitoring of activities within the University reservations at Ampasit, Sadjatan, Timoy, Puguis, Balili, Talinguroy, Wangal, Gayasi, Buyagan, Lubas, Tawang, Cabanao and Tabangaoen and Swamp area. Profiling of the BSU Reservations continued during the year where claimants were interviewed and biodiversity assessment was conducted.





In connection to the University's reservations, 33 of the 34 civil cases which were handled by the Legal Office during the year were on landholdings. 8 are at Regional Trial Courts, and 25 at the Municipal Trial Court. Three additional cases are being investigated at the Community Environment and Natural Resources Office (CENRO).

V. UPGRADING OF PHYSICAL FACILITIES AND PROVISION OF SUPPLIES


The construction new buildings and the improvement or repair of existing facilities were continuously conducted in 2016. Twenty (20) infrastructure projects were implemented and at the end of the year, eleven (11) infrastructure projects were completed, seven (7) were still ongoing, one (1) was awarded but was not yet started, and one (1) was ready for bidding. Thirteen (13) of the projects were contracted out while six (6) were implemented "by administration". These projects were jointly facilitated by the Procurement and Management Office (PMO), the Planning and Development Office (PDO) and Finance Sector.



The rehabilitation and repair of existing facilities were conducted by the General Services Office (GSO). Eighty two (82) projects were implemented during the year, 60 of which were programmed while the additional 22 projects were unprogrammed and/or urgent, such as those damages caused by typhoons (Table 2). In addition, various pieces of furniture were fabricated and installed in the classrooms/offices. The GSO also conducted maintenance and


upgrading of electrical lights and fixtures and water lines in all buildings in the University. In addition, the fencing project along the mulberry plantation in Balili is also being constructed through *pakyaw* contract.




A total of 48 procurement projects have undergone bidding during the year. Eight (8) projects amounting to Php 4,319,624.46 were delivered, while 25 projects amounting to Php 22,535,980.24 were already awarded but are not yet delivered. The bidding for 13 projects failed, 2 of which were already identified to go through alternative method of procurement (AMP).

Supplies and equipment amounting to Php 85,043,281.08 were received by the Supplies and Property Management Office (SPMO) during the year. On the other hand, the supplies and equipment issued to the various offices in the University amounted to PhP 86,485,775.06.



VI. RECORDS MANAGEMENT



The digitization of records by Records Office continued in 2016. The files which were scanned are Memorandum of Agreement/Understanding

and issuances of the University. For the year, 317 local and 35 international Memorandum Agreement/Understanding were scanned and added to the database. Various databases were also developed in the different offices of the University to improve records management and in the retrieval of information needed in the preparation of reports and in answering queries of employees or outsiders. The CBOO prepared databases for compensations and benefits, benefits of university scholars, and loans of employees. International Relations Office (IRO) prepared a database of the University's past and present international linkages. Copies of MOA/MOU were collected from different offices and are now kept at the IRO. The PDO on the other hand, established databases on a) buildings in the University, and b) housing units and the occupants.

VII. INTERNATIONAL AND PUBLIC RELATIONS

The University accommodated visitors, both from various parts of the country and from other countries. Foreign visitors were assisted by the IRO and local visitors were assisted by the University Public Affairs Office (UPAO).







