Prospective bidders should have completed a contract similar to the project with an amount of at least 50% of the ABC within five (5) years from the date of submission and receipt of bids. Interested bidders must have key personnel and equipment (owned, leased or under purchase agreement) available for the prosecution of the project. The list of minimum equipment requirement is indicated in the Eligibility Forms.

Bidding shall be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Reform Act".
