2	Gallon-Bleach, liquid, bleach, original, with atleast 3785ml/gallon FDA or EPA / passed quality control approved and expiration date must not be earlier than 6 months from the date of delivery	
3	Gallon-Hand soap, liquid with atleast 3785ml/gallon FDA or EPA / passed quality control approved and expiration date must not be earlier than 6 months from the date of delivery	
4	Cans-Disinfectant spray, minimum of 340 gram/can, no scent, FDA or EPA / passed quality control and expiration date must not be earlier than 6 months from the date of delivery	
5	Pack-Detergent powder, without calcium carbonate (chalk powder) 1kg/pack
