A RESOLUTION DECLARING THE BID OF WI-AL CONSTRUCTION BUILDERS AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD FOR THE PROJECT IB 2023-04 PROCUREMENT OF VARIOUS CONSTRUCTION, ELECTRICAL AND PLUMBING SUPPLIES FOR REPAIR OF VARIOUS BUILDINGS

WHEREAS, the BENGUET STATE UNIVERSITY (BSU) published the Invitation to Bid for the PROJECT IB NO. 2023-04 PROCUREMENT OF VARIOUS CONSTRUCTION, ELECTRICAL AND PLUMBING SUPPLIES FOR REPAIR OF VARIOUS BUILDINGS at the PhilGEPS and BSU websites and posted the same in four (4) conspicuous places, at the La Trinidad Municipal Building, Barangay Balili Building, Barangay Betag Building and the University Bulletin Board continuously starting on November 17, 2022 to December 7, 2022;

WHEREAS, in response to the invitation, only WI-AL Construction Builders submitted its bid on or before the scheduled submission at 10:00 am on December 7, 2022;

WHEREAS, after checking of the eligibility requirements submitted, the sole bidder was declared eligible. Thus, its financial documents were opened.

WHEREAS, after careful examination and verification of the eligibility requirements and financial proposal of the eligible bidder and having been post qualified by the Bids and Awards Committee, with the assistance of the Technical Working Group (TWG), the bid of WI-AL Construction Builders was determined to be Single Calculated Responsive Bid (SCRB).

NOW THEREFORE, in the light of the foregoing considerations, be it RESOLVED as it is hereby RESOLVED:

1. To declare the bid of WI-AL Construction Builders as the Single Calculated Responsive Bid (SCRB).

2. To recommend to the University President, FELIPE SALAING COMILA. the approval and awarding of items in the SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION, ELECTRICAL AND PLUMBING SUPPLIES FOR REPAIR OF VARIOUS BUILDINGS as reflected in the Abstract of Bids, at its bid price of Four Million Six Hundred Thirty Nine Thousand One Hundred Thirteen Pesos Only (Php. 4,638,888.00).
