DECLARING THE BID OF MARY BELLE ACOB TULLAO TRADING AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD FOR THE PROJECT IB 2019-19 PROCUREMENT OF ONE (1) LOT VARIOUS JANITORIAL SUPPLIES

WHEREAS, the BENGUET STATE UNIVERSITY (BSU) published the Invitation to Bid for the **PROJECT IB NO. 2019-19, PROCUREMENT OF ONE (1) LOT VARIOUS JANITORIAL SUPPLIES** at the PhilGEPS and BSU websites and posted the same in four (4) conspicuous places, at the Provincial Capitol Building, La Trinidad Municipal Building, Barangay Balili Building and the University Bulletin Board continuously starting on November 8, 2019 to November 26, 2019;

WHEREAS, in response to the invitation, only MARY BELLE ACOB TULLAO TRADING submitted its bid on or before the scheduled submission at 9:00 am on December 2, 2019;

WHEREAS, after careful examination and verification of the eligibility requirements and financial proposal of the eligible bidder and having been post qualified by the Bids and Awards Committee, with the assistance of the Technical Working Group (TWG), the bid of MARY BELLE ACOB TULLAO TRADING was determined to be Single Calculated and Responsive Bid (SCRB) for the project.
