Security agency guards are subjected to direct supervision of the Chief Security Officer with the assistance of other Plantilla guards who may conduct random post to post inspection.





GUARD RESPONSIBILITIES AND DUTIES specifically within identified areas:

- Guard must always observe proper courtesy and discipline.
- · At all time, guard must be in proper uniform with smart bearing
- As front-line of defense, always observe proper decorum and must familiarizes himself with the policies, buildings, training halls, and employees of the University.
- Incoming guard must be on his assigned post at least 15 minutes before the time and outgoing guard leave his post to ensure proper turnover.
 - Closely monitor AOR, Arrest violator/s of illegal cutting of pine trees, bamboo and other forest products;
 - Enforce Forest protection laws, assist in the suppression of forest fires and arrest culprits/s;
 - ➤ Implement CITIZENS ARREST on individuals doing excavation, act of land encroachment, squatting and submit necessary report;
 - > At all times, inspect all vehicle coming IN/OUT and maintain vehicle access monitoring log;
 - ➤ Prevent private vehicles from parking inside the CSAC/IFSHA compound without coordination from BSU Management;
 - Prevent individuals from using reservation areas as pasture lands;
 - ➤ Prevent civilian/outsiders for any activities within the reservations/compound without official permission;
 - CSAC gate must be closed at 6:00PM to 6:00AM;
 - > IN NO CASE, LRA shall be used as drinking area of intoxicating liquor/picnic grounds of minors.
