This Supplemental/bid bulletin is being issued to advise prospective bidders to clarify items in the Bidding Documents in response to the clarification from prospective bidders during the Pre-Bid Conference held on August 24, 2023 at 2:00 P.M. at the Rogelio D. Colting (RDC) Hall. The Bidding Documents and all papers previously issued in relation to the aforesaid project are hereby amended as follows:

A. Amended Section 7 - Technical Specifications (highlighted)

1. Item No. 2. 3-units Hotplate with Magnetic Stirrer

Specifications: **Temperature range: 40 to 500 degrees Celsius; timer - optional or 1 min to 100 hours; temperature accuracy +/- 1 degree Celsius; display accuracy 1 degree Celsius; speed range - 100 - 1600 rpm; Capacity: maximum of 1 liter; dimension (L x W x H) at least 20 x 22 x 11 cm (8 x 9 x 4.5") / Manufacturer's Specification; bar length- at least 50 mm; with AVR and 1 year warranty on parts and service.**

2. Item No. 4. 1-unit Centrifuge

Specifications: **Max. speed - 4400 rpm; with a Relative Centrifugal Force of 3000 x g; with soft brake function for slow acceleration and braking; Max. capacity – 15 ml; Dimension (L x W x H) 24 x 39 x 24 cm/ Manufacturer's Specification; Voltage (V/Hz)-AC 220 V,60 HZ with a maximum power consumption of 280 watts; Rotor: acceleration time of at least 15 sec.; Deceleration time of at least 15 secs.; Timer: 10 secs to 10 hours with continuous run function; Soft brake function of 10 ramps; Noise level maximum of 60 dB ; with 100 pieces of 15 ml screw cap centrifuge tubes and compatible AVR.**
