**BENGUET STATE UNIVERSITY**, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having principal office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its University President, **DR. FELIPE SALAING COMILA**;

and

**KENWORTH GO CHAN**, PROPRIETOR of **ADKREATS ARTS AND SIGNS**, a business establishment duly registered as a **Sole Proprietorship** under Philippine Laws having principal addresses at FA 185 Pines Hill Business Center 2, Km. 5, Balili, La Trinidad, Benguet herein referred to as the **SUPPLIER**:

### WITNESSETH:

**WHEREAS**, for purposes of efficiency and economy and consonant with the provisions of R.A. 9184, the Benguet State University requested quotations for the **PRINTING** of Information materials for 2023 from **January 19, 2023 to December 31, 2023**, the particulars of which are contained (annexed A) in the request for quotation, herein called the "PROJECT";

**WHEREAS**, pursuant to the said request of quotation, **GOLD INK PRINTING SHOP, MS PRINTING PRESS & COPY CENTER** and **ADKREATS ARTS AND SIGN** submitted offers that were then processed by the Bids and Awards Committee for Goods and Services pursuant to the provisions of RA 9184;

**WHEREAS**, the offer of **KENWORTH GO CHAN** is found to be the Lowest Calculated and Responsive Quotation (LCRQ) in the amount of **One Hundred Ninety-nine Thousand Six Hundred Eighty Pesos Only (Php 199,680.00)** vis-à-vis the ABC of Two Hundred Thirty-six Thousand Pesos Only (Php 236, 000.00) with the specifications (Type of material: Tarpaulin; Thickness: 0.011-0.012 in (0.28-0.30mm/heavy duty Average job per month is 40 tarpaulins, 4ft x 8 ft standard size. Willing to accept rush printing (within one half day printing) and deliver immediately after printing: 13.00/sq. ft or 416.00) from January 2023 to December 2023;

**WHEREAS**, the corresponding Notice of Award dated January 19, 2023 was issued by **BSU** and which was conformed to by the **SUPPLIER** on the same date;

**NOW THEREFORE**, for and in consideration of the mutual commitments herein set forth, both contracting parties hereto have voluntarily agreed to the following terms, conditions and stipulations:

- 1) That the duration of the contract shall be from **January 19, 2023 to December 31, 2023**;




