THIS AGREEMENT made the 30th day of January 2024between:

BENGUET STATE UNIVERSITY, a state-owned educational institution with address at La Trinidad, Benguet, Philippines hereinafter called "the university", represented in this agreement by its University President, **DR. FELIPE SALAING COMILA**;

ALLEN A. TOLDING, Sole Proprietor of CATALYST COMPUTER OFFICE EQUIPMENT WHOLESALING, a business establishment duly registered as a Sole Proprietorship under Philippine Laws having principal addresses at Betag, La Trinidad, Benguet herein referred to as the SUPPLIER;

WHEREAS the BENGUET STATE UNIVERSITY invited Bids for the supply of certain goods and ancillary services, for the project IB 2024-09, as detailed on the table below.

WHEREAS after compliance with the procurement law BSU has accepted the bid by the Supplier for the supply of those goods and services in the sum of Three Million Three Hundred Twenty-Two Thousand Five Hundred Pesos Only (PHP 3,322,500.00.00), hereinafter called "the Contract Price" vis-à-vis the ABC of Five Million Forty-Five Thousand Nine Hundred Eighty Pesos Only (PhP 5,045,980.00).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Three Million Three Hundred Twenty-Two Thousand Five Hundred Pesos Only (PHP 3,322,500.00.00), or such other sums as may be ascertained, ALLEN A. TOLDING agrees to supply and deliver the goods and services under project IB NO. 2024-09: Procurement of various Information Technology (IT) Equipment for Benguet State University (Early Procurement Activity- EPA), particularly 66 units Desktop Computers,6 units Camera and 14 units Televisions in accordance with his/her/its Bid.
- 4. The **BENGUET STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
