This Contract made and entered into this 23rd day of August 2023 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA;**

And

PRO MAINTECH CONSULTANCY, INC. a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and principal address at Block 9, Lot 14 St., Camella Homes Alabang-2E, 1772 Muntinlupa City represented by its Sales Executive **MARIFE S. ANTONIO** herein referred to as the **"SUPPLIER"**.

WITNESSETH

WHEREAS, consonant to the provisions of R.A 9184, the BENGUET STATE UNIVERSITY posted an Invitation to Bid for the project: IB 2023-19 Procurement of various Laboratory Equipment in the PhilGEPS, agency website and four (4) conspicuous places continuously for seven (7) days starting May 31, 2023;

WHEREAS, in response to the Invitation, fourteen (14) bidders bought and submitted their bids on the scheduled submission at 2:00 PM of June 20, 2023, of which Pro Maintech Consultancy, Inc. was one who submitted their bid proposal;

WHEREAS, during the opening of bids, the legal, technical and financial requirements submitted by all the bidders, the bid of Pro Maintech Consultancy, Inc. was declared eligible, thus the financial offer was opened;

WHEREAS, upon series of post qualification, the bid of Pro Maintech Consultancy, Inc. for items number 2 and 5 (1 unit UV-VIS Spectrophotometer and 1 unit Water Purification System) were found to be responsive to the requirements of the project;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and statements in its bidding documents, the bid of the herein SUPPLIER was found to be compliant and responsive to the requirements of the project. Hence, on July 27, 2023 and August 18, 2023 under BAC Resolution Number 2023-596 and 2023-597 respectively, the Bids and Award Committee declared the bid of Pro Maintech Consultancy, Inc. as the Lowest Calculated and Responsive Bid (LCRB) for two (2) items of the project (items Number 2 and 5);

Pro Maintech Consultancy, Inc.

WHEREAS, the University has accepted the bid offer of the Supplier in the amount of One Million Eighty One Thousand Three Hundred Thirty Pesos only (Php. 1,081,330.00), hereinafter called the "Contract Price vis-à-vis the Approved Budget for the Contract amounting to One Million Three Hundred Fifty Thousand Pesos only (Php. 1,350,000.00)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
 Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidders agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of One Million Eighty One Thousand Three Hundred Thirty Pesos only (Php. 1,081,330.00)) or such other sums as may be ascertained, PRO MAINTECH CONSULTANCY, INC. agrees to particularly Supply, Delivery and Installation of Various Laboratory Equipment - IB 2023-19 in accordance with his/her/its Bid.
- 4. That the Contract time will be for a period of Ninety (90) calendar days; counted from the supplier's receipt of the Notice to Proceed;
- 5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
