**BENGUET STATE UNIVERSITY (BSU)**, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having principal office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA**;

and

**J & LENG CONSUMER GOODS WHOLESALING** a corporation duly organized and existing in accordance with the laws of the Republic of the Philippines, and with principal address at Market Sur, Twin Peaks, Tuba Benguet represented by its proprietor, **JASSER G. GABAYNI** hereinafter referred to as the **"SUPPLIER"**;

**W I T N E S S E T H:**


**WHEREAS**, consonant with the provisions of R.A. 9184, the Benguet State University posted an Invitation to Bid (ITB) for **IB. NO. 2023-02: PROCUREMENT OF VARIOUS CONSTRUCTION, PLUMBING, CARPENTRY, ELECTRICAL, ELECTRONIC SUPPLIES AND FIXTURES**, the particulars of which are contained in the Invitation to Bid (Annex A);

**WHEREAS**, pursuant to the said invitation, **J & LENG CONSUMER GOODS WHOLESALING** dropped its bids. Upon thorough evaluation and verification of all the bidding documents and all the statements made therein, and having been post qualified by the TWG and end-users, the bid of **J & LENG CONSUMER GOODS WHOLESALING** was determined as the Single Calculated and Responsive Bid (SCRB) pursuant to the procurement law.

**WHEREAS**, the amount of the contract is Seven Hundred Twenty-Five Thousand Sixty-seven Pesos and Thirty-one Centavos Only (Php. 725,067.31);

**NOW THEREFORE**, for and in consideration of the mutual commitments herein set forth, both contracting parties hereto have voluntarily agreed to the following terms, conditions and stipulations:

- 1) That the duration of the contract shall commence Thirty (30) Calendar Days upon receipt of Notice to Proceed (NTP);
- 2) The following documents shall be attached, deemed to form, and be read and construed as part of this agreement, to wit:
  - a) Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- d) Notice of Award of Contract; and the Bidder's conforme thereto; and
- e) Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
- 3) The SUPPLIER shall deliver without delay the required information technology equipment on the indicated Purchase Orders (PO) set by BSU with due regard to the needed lead time for processing;
- 4) Payments shall be made by the University to the supplier depending on the details of Purchase Order and other bid proposals/delivered by the supplier, duly accepted by the procuring entity in accordance with the specifications, and upon billing;


