This Contract made and entered into this 15th day of June 2023 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA;**

And

THEINNOMED ENTERPRISE, a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and principal address at # 27C Don Mario St. Don Antonio Heights, Quezon City represented by its authorized representative RIOMELLE UNTALAN herein referred to as the "SUPPLIER".

WHEREAS, the BENGUET STATE UNIVERSITY invited Bids for certain goods and ancillary services, particularly SUPPLY, DELIVERY AND INSTALLATION OF LABORATORY EQUIPMENT FOR THE VETERINARY TEACHING HOSPITAL (VTH) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million One Hundred Nineteen Thousand Nine Hundred Pesos (Php. 1,119,900.00), hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;

 Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response

to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract; and the Bidder's conforme thereto; and
- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidders agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of One Million One Hundred Nineteen Thousand Nine Hundred Pesos (Php. 1,119,900.00) or such other sums as may be ascertained, INFINNOMED ENTERPRISES agrees to particularly Supply, Delivery and Installment of Laboratory Equipment for the Veterinary Teaching Hospital (VTH)- IB 2023-14 in accordance with his/her/its Bid.
- 4. That the Contract time will be for a period of **Thirty (30)** calendar days; counted from the supplier's receipt of the Notice to Proceed;
- 5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
