This Contract made and entered into this 15th day of June 2023 by and between:

WHEREAS, the **BENGUET STATE UNIVERSITY** invited Bids for certain goods and ancillary services, particularly **SUPPLY, DELIVERY AND INSTALLATION OF LABORATORY EQUIPMENT FOR THE VETERINARY TEACHING HOSPITAL (VTH)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million One Hundred Nineteen Thousand Nine Hundred Pesos (Php. 1,119,900.00)**, hereinafter called the **“Contract Price”**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
Bid form, including all documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder’s response

In consideration of the sum of One Million One Hundred Nineteen Thousand Nine Hundred Pesos (Php. 1,119,900.00) or such other sums as may be ascertained, **INFINNOMED ENTERPRISES** agrees to particularly Supply, Delivery and Installment of Laboratory Equipment for the Veterinary Teaching Hospital (VTH)- IB 2023-14 in accordance with his/her/its Bid.
4. That the Contract time will be for a period of **Thirty (30)** calendar days; counted from the supplier's receipt of the Notice to Proceed;
5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
