This Contract made and entered into this 14th day of December 2023 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA;**

And

168 PARAGON INTERNATIONAL GENERAL CONTRACTOR a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and principal address at 110-C kaingin Road, A. Samson 1, Quezon City represented by its Owner, **MANOLITO L. ONG** herein referred to as the **"SUPPLIER".**

WITNESSETH

WHEREAS, consonant to the provisions of R.A 9184, the BENGUET STATE UNIVERSITY posted an Invitation to Bid for the project: IB 2023-28 Procurement of Various Baking Machines for Bakery Project in the PhilGEPS, agency website and four (4) conspicuous places continuously starting on September 18, 2023;

WHEREAS, in response to the Invitation, DM Baylon Manufacturing and Industrial Inc. and 168 Paragon Int'l General Contractor & Equipment bought and submitted their bids on the scheduled submission at 2:00 PM of October 10, 2023;

WHEREAS, during the opening of bids, the legal, technical and financial requirements submitted by the bidders, D.M Baylon Manufacturing and Industrial Inc. and 168 Paragon Int'l General Contractor & Equipment were declared as eligible and, thus subject of post qualification;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and the statement made in its bidding documents, the bid of the herein SUPPLIER was found to be compliant and responsive to the requirements of the project. Hence, on November 21, 2023 under BAC Resolution Number 2023-1049, the Bids and Award Committee declared 168 Paragon International General Contractor as the Lowest Calculated and Responsive Bid (LCRB) for Item no. 7 Semi-automatic Bag Closing Machine;

WHEREAS, after compliance with the Procurement law, BSU has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Five Thousand Three Hundred Seventy-Three Pesos (Php. 205,373.00)**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
 Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of Two Hundred Five Thousand Three Hundred Seventy-three Pesos (Php. 205,373.00) or such other sums as may be ascertained, 168 PARAGON INTERNATIONAL GENERAL CONTRACTOR agrees to supply and delivery of item no. 7 Semi-Automatic Bag Closing Machine under the project IB No. 2023-28 Procurement of Various Baking Machines for Bakery Project in accordance with his/her/its Bid.
- **4.** That the Contract time will be for a period of **Forty-five (45)** calendar days; counted from the supplier's receipt of the Notice to Proceed;
- **5.** The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
