Scope of Bid</b></p> <p>The Procuring Entity, <i>BENGUET STATE UNIVERSITY (BSU)</i> invites Bids for the <u>Repair of the College of Teacher Education (CTE) Building</u>, with Project Identification Number IB 2023-29</p> <p>The Procurement Project (referred to herein as “Project”) is for the construction of Works, as described in Section VI (Specifications).</p> <p><b>2. Funding Information</b></p> <p>2.1. The GOP through the source of funding is <u>2022 FLR GAA- Capital Outlay in the amount of Three Million Three Hundred Twenty Five Thousand pesos only (Php. 3,325,000.00).</u></p> <p>2.2. The source of funding is: NGA, <u>GAA – MOOE</u></p> <p><b>3. Bidding Requirements</b></p> <p>The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manual and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.</p> <p>Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or invitation to bid by the BAC through the issuance of a supplemental or bid bulletin.</p> <p>The Bidder, by the act of submitting its Bid, shall be deemed to have inspected the site, determined the general characteristics of the contracted Works and the conditions for this Project, such as the location and the nature of the work; (b) climatic conditions; (c) transportation facilities; (c) nature and condition of the terrain, geological conditions at the site communication facilities, requirements, location and availability of construction aggregates and other materials, labor, water, electric power and access roads; and (d) other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.</p>

Opening and Preliminary Examination of Bids</b></p> <p>18.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in the Invitation to Bid (<b>IB</b>). The Bidders’ representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.</p> <p>In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.</p> <p>18.2.
