	A. SCOPE OF SERVICES	
	A. 1. The Fleet Card Service Provider shall provide fuel, oil, lubricants, and other service requirements of BSU-La Trinidad Campus using the fleet card technology. It must ensure that the fleet card technology is protected from duplication or hacking.	
	A. 2. The Fleet Card Service Provider must: A. 2.1 Have a wide service station network nationwide to dispense the fuel requirements of the BSU-La Trinidad	

	Campus service vehicles and equipments following the terms and conditions set in the contract.	
	A. 2.2 Have a web-based program for data tracking or monitoring reflecting the monthly purchases to which the BSU-La Trinidad Campus point person will be given access.	
	A. 3. The Fleet Card Service Provider shall provide the BSU-La Trinidad Campus with fleet card for each enrolled vehicles and a card for various equipment.	
	A. 4. The Fleet Card Service Provider shall provide additional fuel cards, if necessary, upon written request of the BSU-La Trinidad Campus under the same terms and conditions.	
	B. RESPONSIBILITIES OF THE FLEET CARD SERVICE PROVIDER	
	B. 1. The Service Provider shall allow withdrawal of the required fuel, oil and lubricants products by BSU-La Trinidad Campus based on entitlements of, enrolled/listed Fleet Card, in all of its participating branches/stations, only upon presentation of duly approved transation slip	
	B. 2. Issue a transaction slip/invoice to BSU- La Trinidad Campus every time a fuel, oil and lubricants is withdrawn or other services are given/rendered.	
	B.3. Issue the accurate monthly Statement of Account duly accompanied by a receipt/invoice issued by the service station.	
	B.4. Ensure that the fuel card transaction slip accurately reflects any and all purchases charged to the fleet card.	
	B. 5. Provide updates to BSU-La Trinidad Campus in case a new gasoline station is added by the company.	
	B. 6. May conduct an orientation for the designated drivers/personnel of the Motorpool Section regarding the use of fleet card upon its delivery.	
	C. PAYMENT SCHEME	
	Payment will be done on a monthly basis upon submission of the service provider of its Statement of Account/billing statement. In case of price increase and/or rollback on petroleum products, payment shall be based on the prevailing retail pump price at the time of withdrawal.	
	D. DURATION OF CONTRACT	
	The duration of the contract will be until December 31, 2024.
