Project Location	Strawberry Fields, BSU Compound, Km 6, La Trinidad, Benguet
Brief Description	The project is the construction of a gravel concrete parking area with an area of 1,164.40 square meters. It consists of excavation works, compaction, gravel overlay, and concreting of lined canal.
Approved Budget for the Contract (ABC)	PhP. 730,000.00
Contract Duration	20 calendar days
Source of Fund	BAPTC Fund
Amount of Bidding Documents	Php. 1,000.00

Prospective bidders should have completed a contract similar to the project with an amount of at least 50% of the ABC within five (5) years from the date of submission and receipt of bids. Interested bidders must have key personnel and equipment (owned, leased or under purchase agreement) available for the prosecution of the project. The list of minimum equipment requirement is indicated in the Eligibility Forms.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the “Government Reform Act”.
