This Contract made and entered into this 25th day of July 2023 by and between:

BENGUET STATE UNIVERSITY, a chartered public educational institution of higher learning, established and existing under the laws of the Republic of the Philippines having office at La Trinidad, Benguet, herein referred to as **BSU** and represented by its President, **DR. FELIPE SALAING COMILA;**

And

LEVINS INTERNATIONAL CORPORATION a business entity duly organized and existing in accordance with the laws of the Republic of the Philippines, and principal address at # 159 Congressional Ave., Brgy. Toro 1, Quezon City represented by its Professional Sales Representative **TYRONE JOHN D. RICALDE** herein referred to as the **"SUPPLIER".**

WITNESSETH

WHEREAS, consonant to the provisions of R.A 9184, the BENGUET STATE UNIVERSITY posted an Invitation to Bid for the project: IB 2023-18 Supply, Delivery and Installation of various Laboratory Equipment in the PhilGEPS, agency website and four (4) conspicuous places continuously for seven (7) days starting May 24, 2023;

WHEREAS, in response to the Invitation, Levins International Corp. and Mt. Zion Scientific Inc. bought and submitted their bids on the scheduled submission at 2:00 PM of June 13, 2023;

WHEREAS, during the opening of bids, the legal, technical and financial requirements submitted by the bidders, both Levins International Corp. and Mt. Zion Scientific Inc. were declared as eligible and, thus subject of post qualification;

WHEREAS, upon careful examination, validation and verification of the legal, technical and financial requirements submitted and stated in its bidding documents, the bid of the herein SUPPLIER was found to be compliant and responsive to the requirements of the project. Hence, on July 13, 2023 under BAC Resolution Number 2023-559, the Bids and Award Committee declared Levins International Corp. was declared as the Lowest Calculated and Responsive Bid (LCRB) for the project;

WHEREAS, the University has accepted the bid offer of the Supplier in the amount of One Hundred Sixty Six Thousand Pesos only (Php. 166,000.00), hereinafter called the "Contract Price vis-à-vis the Approved Budget for the Contract amounting to (Php. 253,500.00)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or bid bulletin, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statement submitted;
 Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidders agrees that additional documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of **One Hundred Sixty Six Thousand Pesos only** (Php. 166,000.00) or such other sums as may be ascertained, **LEVINS INTERNATIONAL CORP.** agrees to particularly Supply, Delivery and Installment of Various Laboratory Equipment IB 2023-18 in accordance with his/her/its Bid.
- 4. That the Contract time will be for a period of Forty-Five (45) calendar days; counted from the supplier's receipt of the Notice to Proceed;
- 5. The Benguet State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
