GUIDELINES/MECHANICS IN RANKING OFFICES/DELIVERY UNITS FOR THE GRANT OF PERFORMANCE-BASED BONUS (PBB) FY 2017

The Performance Management Team (PMT) consisting of senior officials that directly oversee and observe the performance of offices or delivery units was tasked by the Head of Agency to establish the guidelines/mechanics in ranking delivery units as basis in the force ranking of the different delivery units of the University for the Performance-Based Bonus (PBB) FY 2017.

To facilitate the ranking of delivery units, the different offices were clustered based on similarities of functions and responsibilities as per the Major Final Outputs (MFOs) and Operations identified.
