RAYMOND P. PACULAN, Sole Proprietor of **GOLDINK PRINTING SHOP**, a business establishment duly registered as a *Sole Proprietorship* under Philippine Laws having principal addresses at G/F T-Alonzo St., Juniper Bldg. Baguio City herein referred to as the **SUPPLIER**;

WITNESSETH:

WHEREAS, the **BENGUET STATE UNIVERSITY** invited Bids for the supply of certain goods and ancillary services, under the project **IB 2023-20A**, as detailed on the table below.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
