

TERMS OF REFERENCE FOR ISO 9001:2015 QUALITY MANAGEMENT SYSTEM (QMS) RE-CERTIFICATION

I. PROJECT TITLE

Engagement of Third-Party Audit Services for the re-certification of the Benguet State University Quality Management System (QMS).

II. ESTIMATED BUDGET FOR THE CONTRACT

Six hundred Forty Thousand Pesos (Php 640,000.00)

III. PROJECT DURATION

Three years (2024-2026)

IV. PROJECT OBJECTIVES

The overall objective of the engagement is to provide an independent audit of the BSU QMS conformance to ISO 9001:2015 requirements. Conduct the required Surveillance Audits and issue Certification for the three campuses.

V. PROJECT DESCRIPTION

The project involves the supply of services of a third-party Certifying Body to conduct recertification audits of the BSU QMS based on ISO 9001:2015 Standard; issue ISO 9001:2015 Certificate; and conduct the surveillance audits within the prescribed period.

VI. QUALIFICATIONS OF CERTIFYING BODY

The Certifying Body must be accredited by the Department of Trade and Industry-Philippine Accreditation Bureau (DTI-PAB) and have conducted the audit services for the current and following two (2) years before the expiration of the Governance Commissions' ISO Certification. Also, the Certifying Body must have the capability to conduct Remote Audit Services if needed aside from other ordinary modes of conducting the audit.

I ELIGIBILITY REQUIREMENTS

A. LEGAL DOCUMENTS

- 1. Valid PhilGeps Registration Platinum Membership- all pages; in accordance with Section 8.5.2 of the IRR
- 2. Registration from SEC, DTI for sole proprietorship, or CDA for Cooperatives, and
- 3. Mayor's or Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas.
- 4. Tax Clearance per E.O. No. 398, s. 2005, as finally reviewed and approved by the BIR

B. TECHNICAL DOCUMENTS

- 5. Statement of the prospective bidder of all ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period as provided in the Bidding Documents. The statement shall include all information required in the PBDs prescribed by the GPPB.
- 6. Statement of the consultant specifying its nationality and confirming that those who will actually perform the service are registered professionals authorized by the appropriate regulatory body to practice those professions and allied professions, including their respective curriculum vitae.

C. FINANCIAL DOCUMENTS

7. The consultant's audited financial statements, showing, among others, the consultant's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission.

8. If applicable, a duly signed **Joint Venture Agreement (JVA)** in case the joint venture is already in existence, <u>or</u> duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful
